



BYLAWS COMMITTEE AMENDMENT

During the Bylaws Committee presentation, the committee brought the amendments before the messengers of the 2021 Annual Meeting including a transition plan that allows for the number of members of the Executive Board to be reduced gradually through natural attrition to the recommended number of members by 2025. Upon bringing forth the amendments, Rev. Keith Davis of Zion Hill in Spartanburg brought forward an amending of the amendment. His proposed change was to have at least one of the two representatives from each region coming from a church of less than 200 members.

Rev. Kenny Moore of Davidson Street in Clinton, speaking in favor of the amendment said, "I know it is not your intent to eliminate anyone or any church, however, prior to the convention last year, churches below 250 had no representation. We have 23 churches in our association that are 200 and less in worship attendance. When this passes, it appears that these churches will lose their voice on the table." The amending of the amendment was brought to a vote and passed.
