Hate Crimes Bill

Hate Crimes legislation progressed in the House through the subcommittee and full committee process. At the time of this writing, the bill is set to be added to the House calendar for a vote. The bill was amended in subcommittee, taking out the civil penalties section (which would have allowed individuals to sue if they were offended by another individual without the necessity of a court procedure) and removing stalking and harassment from being covered by the hate crimes provision. However, sexual orientation and transgender language are still included in the bill. We will be working to remove this language from the bill. If the language survives, it will be the first time in South Carolina that sexual orientation and transgender categories receive official legal recognition.



Save Women's Sports Legislation Stalls

March may have seasonally seen the start of spring for South Carolina, but for social conservatives in the statehouse it was a blast of cold air. The Save Women's Sports bill that would have prohibited biological males from competing against biological females in High School and Middle School was tabled by the House Judiciary Committee. The bill passed the sub-committee and was recommended to the full committee on a 3 to 1 vote. But last minute maneuvering by two upstate House members plus last minute opposition from the Superintendent of Education and the High School



Medical Marijuana

At the writing of this Newsletter, it appeared the Senate Medical Affairs Committee was poised to give a favorable recommendation for so called medical marijuana, (Now known as \$150 "The Compassionate Care Act."). There is no such thing as "medical marijuana." That is a term that is used to confuse the public, making people believe marijuana is FDA approved and is dispensed the way other medications are dispensed. But no FDA approval means it cannot be prescribed by a doctor and it cannot be dispensed by a pharmacy. SLED, The South Carolina Sheriff's Association, and the South Carolina Medical Association are all opposed to this bill. Please call your Senator and your House member. The tabling of the bill for this session was a major setback, but we are not giving up. We are currently working with Palmetto Family, ADF, and other conservative non-profit organizations to revamp the bill and get it ready to be refiled in January. Please pray for the members of the legislature that they will see the importance of protecting female athletes from unfair competition.

FACTS ABOUT MARIJUANA FROM A JUST RELEASED, BIPARTISAN STUDY FROM THE US SENATE CAUCUS ON INTERNATIONAL NARCOTICS CONTOL, MARCH 3, 2021

- No amount of marijuana is safe for adolescents (age 10 to 24).
- Marijuana-impaired drivers threaten public safety, yet no universal detection standards exist.
- Costs of emergency room visits for marijuana related incidents have skyrocketed in recent years and cost millions of dollars.
- One in six of those under 18 who use marijuana will become addicted.
- One in nine users of marijuana will become addicted.
- 30% of users have a marijuana use disorder.
- Research shows the use of marijuana has a negative impact on developing brains (which can be permanent) including:
- Decreased cognitive ability
- Loss of IQ (as much as 8 points)
- Increased risk of psychosis

The current marijuana bill in the Senate allows 18 and under to obtain "medical" marijuana cards if their parent or guardian consents. The bill also provides for 15 cultivation centers in South Carolina before we know anything about the actual demand. Florida, which has four times our population, has only eight centers. This looks like preparation for the eventual legalization of recreational use.
